You will need to write a note and/or check with the school office and your child's teacher.

Please fill out the waiver on the back of this letter and return it, along with the \$5.00 fee, to the Recreation Office no later than Tuesday, January 19th. Participants must have their waiver signed and turned in to the *Greybull Recreation District Office* before they will be allowed to participate in this activity.
